申請「2027/28 幼稚園入學註冊證」

- 政府由 2017/18 學年起落實推行「幼稚園教育計劃」（下稱「計劃」），每名可在本港接受教育的學童只會獲發一張註冊文件，而所有參加「計劃」的幼稚園，只可取錄持有有效註冊文件的學童。
- 家長須於 2026 年 9 月至 11 月期間為其子女向教育局申請「幼稚園入學註冊證」（下稱「註冊證」）。「註冊證」會於本年 9 月開始接受申請，屆時教育局會公布申請細則，並會在教育局網頁<https://www.edb.gov.hk/tc/edu-system/preprimary-kindergarten/kindergarten-k1-admission-arrangements/front.html> 上載詳情。如申請人在遞交申請時已提供全部所需資料及文件，教育局一般可在六至八個星期內完成審核，並以郵遞 / 電郵方式發放「註冊證」給合資格接受「計劃」資助的申請人。
- 如學童可於本港接受教育但不合乎資格接受「計劃」資助而未能獲發「註冊證」，教育局會為有關學童發出「幼稚園入學許可書」（下稱「入學許可書」），學童可憑「入學許可書」註冊並入讀參加「計劃」的幼稚園，惟其家長須按註冊入讀之幼稚園的收費證明書繳付未扣減「計劃」資助前的全額學費。

收生準則

- 申請人的兄弟姊妹現正在本校就讀獲優先考慮。
- 按遞交報名表的先後次序，邀請申請人進行面見。
- 申請人之家長需認同本園之辦學理念，以達致伙伴合作的關係。
- 申請人之家庭識別為有需要接受全日制幼兒學校服務將獲優先考慮（請留意由於學位所限，並非所有符合優先考慮的申請人均會獲取錄。）

取錄結果公布

- 本校將於 2026 年 12 月 11 日前以郵遞方式通知家長 K1 取錄結果。

註冊安排

- 家長須於 2027 年 1 月 7 日至 9 日（「統一註冊日期」）內的指定時間到本校辦理註冊手續，並須提交「註冊證」/「入學許可書」正本及繳交註冊費。
- 家長請留意，如未能在指定的註冊日期提交「註冊證」/「入學許可書」，本校或未能為獲取錄兒童完成手續，因此家長務必於指定日期內向教育局申請相關註冊文件。
- 備取生安排：註冊日後，如仍有學額，本園將盡快以電話通知備取生家長。
- 2027/28 學年的註冊費為港幣 1500 元正。如有關兒童入讀本校，註冊費將會撥作 2027 年 9 月學費的一部份，若家長於註冊後決定為子女轉校，請以書面通知本校退回「註冊證」/「入學許可書」，但註冊費將不獲退還。在取回「註冊證」/「入學許可書」後，本校亦不會再為該兒童保留學位。

Return of Application Forms and criteria of application (No set quota and No time limit for the school):

- A child with a Hong Kong birth certificate.
- Fill in the "application form" and attach a recent photo of child on the form, submit the application form with the following documents and return or mail to the school together:
 - A copy of child birth certificate
 - A copy of Childhood Immunization Record of the Department of Health, the Government of the Hong Kong Special Administrative Region
 - Three return envelopes affixed with sufficient stamps
 - Application fee : HK\$40 (to be collected upon submission of the application form). The application information and application fee is non-returnable whether the application is successful or not.

Application for the "2027/28 Registration Certificate for Kindergarten Admission"

- The Government will implement the "Kindergarten Education Scheme" (hereafter referred to as "Scheme") starting from the 2017/18 school year. Each child who can receive education in Hong Kong will only be issued one registration document and all Scheme-KGs can only admit students holding a valid registration document.
- Parents are required to submit an application for the "Registration Certificate for Kindergarten Admission" (hereafter referred to as "RC") to EDB from September to November 2026. The "RC" will be open for applications in September 2026 and EDB will announce and upload the details of application onto EDB's website <https://www.edb.gov.hk/en/edu-system/preprimary-kindergarten/kindergarten-k1-admission-arrangements/front.html> in due course. Upon receipt of the applications with all necessary information and documents provided, EDB will generally take six to eight weeks to complete processing of the applications and issue the "RC" to applicants who are eligible for receiving subsidy under the Scheme by post / email.
- If a student cannot obtain an "RC" as he/she can receive education in Hong Kong but is not eligible for receiving subsidy under the Scheme, EDB will then issue a "Kindergarten Admission Pass" (hereafter referred to as "AP") to the student concerned for registration and admission to a Scheme-KG but the parents concerned are required to pay full school fees before deduction of subsidy under the Scheme as shown on the Fees Certificate of the KG to which the child is admitted.

Admission Criteria

- The applicant with sibling(s) currently studying in the school will be given due priority consideration.
- Interview will be arranged according to the order of application submission of applicants.
- Parents should agree with the educational philosophy of the school, in order to achieve the relationship of partnership.
- Needy families for full day services will considerate in priority.
(As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place.)

2027/28 Interview Arrangements

- Interviews with K1 applicant will be conducted in November 2026
 - According to registration order of appointment by school-age children, depending on the number of places by appointment.
 - individual interviews with parents and children will be arranged.
 - The applicant selected should submit "Registration Certificate for Kindergarten Admission" / "Kindergarten Admission Pass" and pay the registration fee.
- Interviews with N1(preschool) applicant will be conducted on or before January 2027
 - According to registration order of appointment by school-age children, depending on the number of places by appointment.
 - individual interview with parents and child will be arranged
 - The applicant is required to pay the registration fee to obtain a place.

Interview Time Arrangements

- K1: November 2026
- N1: On or before January 2027

Announcement of Admission Results

We will inform parents of the K1 admission results by post before 11 December 2026.

Registration Arrangements

- Parents should complete the registration procedures for their child from 8 to 10 January 2026 ("Centralized Registration Dates") by submitting the original of the "R C" / "A P" to the school and paying the registration fee.
- Please be reminded that if parents cannot submit the "RC"/ "A P" during registration, the school may not be able to complete registration for their child. Hence, parents are required to submit application for the Registration document to EDB within the specified period.
- Arrangement for Applicants on the waiting list: Our school will contact the parents by phone if there is any vacancy after registration day.
- The registration fee for 2027/28 K1 place is HK\$1500. The registration fee will be allocated for part of the September 2027 tuition fees. Should parents decide to change school after registration, please notify the school in writing. The school will return the "R C"/ "A P" to parents, but the registration fee will not be refunded. Upon obtaining the "R C" / "A P" the school will no longer keep the school place for the child.

服務簡介

協康會成立於 1963 年，一直致力為有不同能力的兒童、青年及其家人提供適切的服務，協助他們盡展所能，建立積極人生。本會透過逾四十個服務單位，為由初生至高中階段、在學習和發展上有困難的兒童及青年提供專業評估、輔導及訓練，其中包括早期教育及訓練中心、特殊幼兒中心、綜合服務中心、青蔥計劃及康苗幼兒園。

為推廣融合教育，協康會於 1999 年更開辦了設有兼收學位的首間幼兒中心－康苗幼兒中心，讓傷健兒童有機會一同學習和成長。

1. 服務宗旨及目標

- 康苗幼兒園旨在為幼兒提供悉心的照料，理想的學習環境，以及優質的學前教育，使他們能在人生的學習過程中，踏出成功的第一步，並能奠下良好的基礎，健康快樂地成長。
- 為二至六歲幼兒提供全日制優質幼兒教育。發掘幼兒的潛能，使幼兒在德、智、體、群、美各方面得到均衡的發展。

2. 服務對象

- 二至六歲兒童(入學前必須通過註冊醫生檢驗及證明適合入讀者)

3. 課程特色

- 由兩歲至六歲共分四級制。以單元為主題配合節令，推行綜合教學，共分十二個月進行。配合兩文三語，設駐校社工、英語會話老師及普通話老師。
- 本校會遵照《幼稚園教育課程指引》(2017)規劃課程，不會要求幼兒班兒童執筆寫字，亦不會要求兒童做機械式的抄寫或操練式的計算練習。
- 以全英語進行英語教學活動。提供活動教學，分組形式進行。按主題需要配以活動，如：外出參觀、計劃活動、科學實驗、慶祝活動、全語文教學活動。

4. 家校協作

- 兒童的成長，全賴家長的悉心照顧與支持，是以協康會一直致力推動家長全面參與兒童的學習，並鼓勵家長間的互相扶持。為有效向政府反映家長們的意見，從而進一步改善服務，家長代表與協康會於千禧年開始努力籌組成立家長會。至 2001 年底，在當時的社會福利署署長林鄭月娥太平紳士的見證下，「同心家長會」宣告成立。
- 康苗幼兒園透過親子旅行、家長小組、家長講座、個別接見家長會、家長聯誼、家訪和面談，與家長作緊密的溝通；亦提供多種途徑讓家長瞭解兒童的活動及課程，如單元學習報告、兒童學習歷程檔案、兒童學習報告等。

5. 師資

- 持有幼兒教育學位或文憑等專業資格、特殊教育學位或證書資格、急救証書。

6. 健康膳食

- 按照營養師建議為幼兒設計均衡營養食譜。
- 學校每天為兒童提供營養均衡的膳食和餐點，包括早餐、午餐、水果、下午茶點及飲品等。

7. 服務範圍

- 一般幼兒學校服務
- 暫託服務
- 幼稚園暨幼兒中心兼收計劃

8. 服務時間

- 星期一至五 上午 8 時至下午 6 時
- 星期六 上午 8 時至下午 1 時
- 星期日及公眾假期休息，每年聖誕節、農曆新年及暑假假期，幼兒園會在手冊行事曆預早通知。

9. 收費-按教育局核准收費(2026-2027)

- 每月學費連膳食港幣 3500 元(N1 班學生)(未扣除\$1000幼兒中心家長津貼)
- 每月學費連膳食港幣 1961元(2026年 9 月至 2027 年 8 月 K1-K3 班持有幼稚園入學註冊證的學生)
- 有需要的家庭可向學生資助處申請幼稚園及幼兒中心學費減免計劃

Heep Hong Society Healthy Kids Nursery School

Since 1963, Heep Hong Society has been providing professional training and education to children to child and youth of different abilities and their families, with the mission of helping them develop their potential and lead a fulfilling life.

Heep Hong Society is committed to providing professional care, education, training and family support services to children from birth to studying in senior secondary schools who have developmental and learning problems.

We have over 40 service units, including Early Education and Training Centers(EETCs), Special Child Care Centers(SCCCs), Mixed-mode Centers, Supportive Learning Project(SLP) and Healthy Kids Nursery School.

To promote integrated education, Heep Hong started to operate an ordinary child care center with an integrated programme for children with mild disability in 1999.

1. Mission

- Healthy Kids Nursery School is a child care center cum kindergarten providing a healthy and happy environment for children with normal intelligence to learn and grow, and to lay a solid foundation for their later learning.
- We offer full-time quality early childhood education for children aged 2 to 6 years old. We seek to exploit children's potentials and empower them to attain balanced development in moral, intellectual, physical, social and aesthetic aspects.

2. Target Service Recipients

- Children aged two to six (Medical certificate certifying child fit for schooling issued by registered doctor should be obtained before start of school).

3. Curriculums

- Our curriculum is divided into four levels of programs for children aged 2 to 6 years old. Through seasonal unit themes, we teach an integrated curriculum that consists of twelve monthly programs. Following the Bilingualism Policy, we have social workers, native English teachers and Mandarin teachers in residence.
- We will follow the "Kindergarten Education Curriculum Guide"(2017) to plan curriculum. Children of nursery classes will not be asked to write, and there will not be mechanical copying exercises and drills on calculation.
- We adopt an English immersion approach for English teaching. We introduce an activity-based teaching method in which children are grouped to take part in various activities. Based on subject needs, we organize activities including outdoor visits, planned activities, scientific experiments, celebrations and whole-language teaching.

4. Home-School Cooperation

- Parents' care and support plays a key role in the healthy growth of children with special needs. In bringing up their children, these parents are under greater stress than parents of normal children. In view of this, Heep Hong Society is committed to serving the needs of parents. Since early 90s, various service units, such as Parents Resource Centers, Parents Association and Fathers' Club have been set up to provide a wide range of services and support to parents of our children.
- We develop intimate interactions between parents through parent-child school picnic, parenting groups, parental seminars. Interviews with individual parents, home visits and so on. Parents have in-depth understanding toward children through learning report and portfolio.

5. Professionals

- We employ teachers who have been professionally trained for pre-school services.

6. Health Meal

- Design a balanced and nutritious meal plan for young children according to the recommendations of dietitians.
- We provide children with nutritious breakfast, lunch, tea and fruit every day.

7. Scope of Service

- Early Childhood Education Service
- Occasional Child Care Service
- Integrated Program for mentally and physically challenged children

8. Service Hours

- Monday – Friday 8:00am – 6:00pm
- Saturday 8:00am – 1:00pm
- Close for Sunday and public holidays. School holidays show on the school year calendar

9. School Fee-Authorized by EDB (2026-2027):

- \$3500/month (Pre-Nursery Class) (Without deducting the \$1,000 Child Care Centre Parent Subsidy)
- \$1961/month(Children who have Registration Certificate for Kindergarten Admission from Sep 2026 to Aug 2027)
- Parents can apply for Kindergarten and Child Care Center Fee Remission Scheme of Student Finance Office.

10. Support to Non-Chinese Speaking (NCS) Students Service

- We arrange interpretation and/or translation service for applicants as necessary, or allow parents and children to be accompanied by a Chinese speaking relative/friend during the interview to facilitate communication.
- Assist in arranging communion activities
- Contact with parents of school children
- Purchase teaching resources
- Organize cultural inclusive activities
